National Association for Patient Participation Theme: "My caring hero" Drawing Competition Terms and Conditions 1st June 2020

Entering the Competition

- 1. The drawing competition (the "Competition") is open to children living in the UK aged between 7 and 10 years old ("You"), at any point during the competition period of 1st June 2020 10th July 2020.
- 2. To enter the Competition, the artwork should reflect the theme "My caring hero".

We are looking for artwork that celebrates our health and care heroes, and their different jobs that give us a healthy and happy life.

The artwork needs to fulfil the following criteria (the "Entry"):

Be drawn on plain, landscape A4 paper

- Be the original work of the Entrant
- Not infringe the rights of any other party or contain any trademarked characters or logos
- Not contain defamatory, obscene, offensive or any other unsuitable material
- Be suitable to be published and used online by The Organiser and/or their agents for audiences of all ages
- Show a clear picture incorporating the child's entire drawing with no shadows visible
- Not be edited prior to upload

Entrants and their parent/guardian must give assurances that any Entry submitted is the original work of the child and agrees to indemnify the Organiser and/or their agents against any claim if this is not the case.

Winning entries will be asked to provide a HD image of the entry.

In the **Subject** box of your email, you should put your name, and in whole years, your age. For example - Debbie Hill, age 7

- 4. When submitting your Competition entry, You must provide your name, age and address and the name and contact telephone number of your parent or guardian. We will only use this information in relation to the Competition (including checking your eligibility to enter it) and will not use it for any other purposes whatsoever. We will not keep this information for longer than is necessary for the operation of the Competition.
- 5.1 You may only send one entry to the Competition.
- 5.2 The maximum number of entries to be judged will be the first 2,000 received.
- 6. We must receive your entry to the Competition by 11:59 pm on 10th July 2020.

7. Employees or agents of the National Association for Patient Participation, ("N.A.P.P.", "We", "the Organiser"), its group companies or their family members may not enter the Competition.

Picking the winners

- 8. The **Head Judge** will choose the winning entries (one winner, two runners up, and up to 10 highly commended) for the Competition from a long list chosen by the following Judges, supported by the N.A.P.P Trustees and CEO:
 - President of the Royal College of GPs, Amanda Howe (Head Judge),
 - Director, Chalkhill Contemporary Art, Annabel Agace
 - Metropolitan Grand Almoner, Treasurer of Florence Nightingale Lodge, Darrell Palmer
 - Chairman of the N.A.P.P. Board, Folarin Majekodunmi
 - Past joint Chairman of the Practice Management Network, Jo Wadey; and
 - President of the N.A.P.P.'s Nominee, Roxy Russell
- 9. The winning entries will be those from the longlist that the **Head Judge** considers to be the most interesting, creative and original.
- 10. The **Head Judge's** decision will be made on or before 31st July 2020. The decision is final and no correspondence will be entered into.

Publishing the winning entries

- 11. The winning entries will be published on the N.A.P.P. web site at www.napp.org.uk/competition from 1st August 2020 or (if N.A.P.P. needs to delay this publication for any reason) at a later date.
- 12. You own the copyright to your Competition entry as its author.
- 13. By submitting an entry to the Competition, You give GNM: a. Permission for your entry to be published on the N.A.P.P. website, and grant N.A.P.P. a non-exclusive, royalty-free, worldwide licence to republish your Competition entry in electronic format, calendar, and hard copy for purposes connected with the Competition; and b. The right to use your name, age and town or city of residence for the sole purpose of identifying You as the author of your entry.

Getting consent from an adult

- 17. The winner will receive a £150 art gift voucher. Two runners up will each receive a £75 art gift voucher. The Judges may also award up to ten Highly Commended awards, which will each receive a £20 art gift voucher.
- 18. The parents or guardians of the winner and the two runners up will be notified by telephone on or before 1st August 2020.
- 19. The prizes will be sent to the winner and the two runners up by N.A.P.P. by **21**st **August 2020.**
- 20. The prizes cannot be exchanged or transferred by You and cannot be redeemed by You for cash or any other prizes.
- 21. We will substitute the prizes with other prizes of similar value in the event that the original prizes offered are not available.

Some other rules

- 22. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
- 23. We take no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt.
