4. Family and Friends Test

Responses to the Family and Friends Test were detailed in the most recent Practice Newsletter. Updates on comments were provided as follows:-

- JC reported that NHS England may be providing TVs to all practices to enable information to be relayed in waiting rooms. Further details are awaited
- JC reported that a plastic sheet had been installed at the end of the reception desk to try and improve privacy between reception and the waiting room
- On the matter of equipment and appearance of the practice JC stated that the practice is allocating resources to make improvements e.g. with external painting. Work is ongoing to rationalise the leaflet displays. All toys have been removed from the waiting area on the advice of a recent Control of Infection audit.

- Access to NHS Facilities: AW-K reported that on a recent visit to Heath Hill Rd Surgery he had noticed a poster from Healthwatch detailing how to access NHS facilities, e.g. out of hours. He will investigate to see if one can be provided for this surgery
- Appointments: JC reported that appointments can be made up to a month in advance. The practice provides extended opening on 2 evenings a month and 2 Saturday mornings.

- JC stated that Dr Evans is looking at improving phone systems. The practice is also investigating providing appointments for people to speak to a doctor by phone
