# 13. Information from the Practice

A new receptionist, Chelsie, started in September

Becky, practice nurse, returned from maternity leave at the beginning of November.

Fiona is now taking nurse and nurse practitioner clinics.

A new phone message is being recorded by Dr Evans to explain why triage is being used. Hopefully this will reduce abuse from patients. Reception is getting increasingly busier.

'Footfall' is being delayed as there are funding issues by NHS England. It will be compulsory.

Project HERE (Workflow Optimisation Project) is a new concept to utilise the skills of Clinical Personal Assistants to support practices with administration workload reduction and joint collaborative working on joint projects. DW will be taking on this 'Project' and will undergo intensive training to read, code and action incoming clinical correspondence safely and accurately. The aim is for up to 80% of patient correspondence to be completed without input from the GP.

CHASC Team is part of a new Anticipatory Care enhanced service (Community Health & Social Care Teams). Patients with more than three non elective admissions to hospital will be monitored.

Jo, the diabetic nurse, will either be leaving at the end of the year, or reduce her hours to only working Saturdays.
